EDUCATION ACT (CAP. 327)

Certificate in Engineering Sciences Course Regulations, 2020

IN EXERCISE of the powers conferred upon him by articles 74 (5) and 75 (6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following regulations made by the Senate of the University of Malta by virtue of the powers conferred upon it by articles 75 (3) and 79 (b) of the said Act:

Citation and Interpretation

- 1. (1) These regulations may be cited as the Certificate in Engineering Sciences Course Regulations, 2020.
 - (2) In these regulations, unless the context otherwise requires -

"the Board" means the Board of the Faculty of Engineering;

"the Board of Studies" means the Board of Studies appointed by Senate for the Course, on the recommendation of the Board;

"the Certificate" means the Certificate in Engineering Sciences; and

"the Course" means the programme of study leading to the Certificate in Engineering Sciences.

Applicability

2. These regulations shall be applicable for courses commencing in October 2020 or later.

Requirements for Admission

3. (1) To be registered as regular students in the Course, applicants shall:

- either (a) satisfy the general requirements for admission as specified in the Admissions Regulations and be in possession also of a pass at Advanced Matriculation Level in one of the following subjects: Pure Mathematics, Applied Mathematics, Physics, Chemistry, Computing, Information Technology, Engineering Drawing, Graphical Communication or other science/numeric subjects as approved by the Board;
- or (b) be in possession of a qualification at MQF Level 4 in an engineering domain, as well as passes in the Secondary Education Certificate Examination at Grade 5 or better in English Language, Maltese and Mathematics.

Applicable for courses commencing in October 2022 or later:

3. (1) To be registered as regular students in the Course, applicants shall:

either (a) have obtained a minimum of 36 points in examinations taken as part of the Matriculation Certificate and be in possession of passes in the Secondary Education Certificate Examination at Grade 5 or better in English Language, Maltese and Mathematics together with a pass at Advanced Matriculation Level in one of the following subjects: Pure Mathematics, Applied Mathematics, Physics, Chemistry, Computing, Information Technology, Engineering Drawing, Graphical Communication or other science/numeric subjects as approved by the Board;

or (b) be in possession of a qualification at MQF Level 4 in an engineering domain, as well as passes in the Secondary Education Certificate Examination at Grade 5 or better in English Language, Maltese and Mathematics.

Applicable for courses commencing in October 2023 or later:

- or (b) be in possession of a diploma in an engineering domain which the Board deems as appropriate, classified at MQF Level 4, as well as passes in the Secondary Education Certificate Examination at Grade 5 or better in English Language, Maltese and Mathematics.
- (2) Applicants may be required to attend for an interview to assess whether they have the necessary aptitude to follow the Course with profit.
- (3) The interviewing board, which shall be appointed for the purpose by the Board, shall be composed of at least three members.

Course Duration

4. (1) The Course shall extend over a period of two semesters of full-time study or four semesters of part-time study.

(2) The Board of Studies may allow students who do not qualify for the Certificate to repeat the Course once only.

Board of Studies

5. The general administration of the Course shall be entrusted to a Board of Studies, approved by Senate.

Programme of Study

- 6. (1) The Course shall consist of a number of taught study-units to which a total of 60 ECTS credits are assigned.
- (2) The programme of study shall be drawn up by the Board of Studies and published by the Board, after approval by Senate, normally not less than eight months prior to the commencement of the Course.

Attendance and Assessment

- 7. (1) Unless otherwise specified in the description of a study-unit, attendance is obligatory for lectures, tutorials, seminars, practicals, and any other teaching session in whatever mode. On the basis of documented evidence, a lecturer may bar a student whose attendance in a study-unit is not satisfactory from being assessed in that study-unit.
- (2) The assessment of each taught study-unit shall be completed by the end of the semester in which the teaching of the study-unit is held.
- (3) Students who fail in a study-unit declared to be compensatable in the programme of study with a mark of not less than 35% shall be awarded the grade CP (Compensated Pass) if their Weighted Year Average Mark is at least 50%. Study-units passed by compensation shall not be re-assessed.
- (4) Students may not be awarded more than 12 ECTS credits through compensated passes.
- (5) Results for the assessment of study-units shall be published as a percentage mark and grade as indicated in the table below:

Both the percentage mark and the grade shall be recorded in the students' academic record.

Award of the Certificate

- 8. (1) The Certificate shall be awarded to students who obtain all the credits indicated in regulation 6.
- (2) The names of students who qualify for the award of the Certificate shall be published in a list in alphabetical order.

Special Provision for Part-Time Courses

9. The provisions of the foregoing regulations shall apply *mutatis mutandis* to courses followed on a part-time basis, and subject to such changes as may reasonably be deemed by the Board of Studies as necessary due to the part-time nature of the Course.

General Provision

10. In matters not provided for by these regulations, the Board shall be guided by the provisions of the General Regulations for University Undergraduate Awards, 2019, published as Legal Notice 248 of 2019, as applicable.

Repeal

11. The Bye-Laws of 2019 in terms of the General Regulations for University Undergraduate Awards, 2004 for the Certificate in Engineering Sciences under the auspices of the Faculty of Engineering, published as Legal Notice 147 of 2019, shall be deemed to cease to be in force as from 1st October 2020, provided that students registered for this course before the 1st October 2020 shall continue to be governed by the bye-laws that were in force at the time of their joining the course.
