**EDUCATION ACT  
(CAP. 327)**

**Bye-Laws of 2010 in terms of the  
General Regulations for University Undergraduate Awards, 2004  
for the Degree of Bachelor of Science (Honours) - B.Sc. (Hons) -  
under the auspices of the Faculty of Health Sciences**

IN EXERCISE of the powers conferred upon him by articles 74(5) and 75(6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following bye-laws made by the Board of the Faculty of Health Sciences in virtue of the powers conferred upon it by section 81 (1) of the said Act and which have been approved by the Senate of the University of Malta as required by section 81 (2) of the said Act:

**Citation and Interpretation**

1. (1) These bye-laws may be cited as the Bye-Laws of 2010 in terms of the General Regulations for University Undergraduate Awards, 2004 for the degree of

Bachelor of Science (Honours) – B.Sc. (Hons) - under the auspices of the Faculty of Health Sciences.

(2) In these bye-laws, unless the context otherwise requires -

“the Board” means the Board of the Faculty of Health Sciences;

“the Board of Studies” means the Board of Studies appointed for each area of study;

“the Course” means the programme of study leading to the degree of Bachelor of Science (Honours) - B.Sc.(Hons);

“the Degree” means the degree of Bachelor of Science (Honours) - B.Sc.(Hons); and

“the Principal Regulations” means the General Regulations for University Undergraduate Awards, 2004.

### **Applicability**

2. These bye-laws shall be applicable for courses commencing in October 2003 or later.

### **Special Course Requirements for Admission**

3. To be registered as regular students in the Course applicants shall, apart from satisfying the general requirements for admission as specified in the Admission Regulations, be in possession of special course requirements depending on the area of study chosen as follows:

#### **Applicable for courses commencing in October 2023 or later:**

##### **Requirements for Admission**

3. To be registered as regular students in the Course applicants shall satisfy the general requirements for admission as specified in the Admission Regulations or have comparable qualifications as indicated below and be in possession of special course requirements depending on the area of study chosen as follows:

(a) **Applied Biomedical Science:** passes at Advanced Level at Grade C or better in Biology and Chemistry; and a pass at Intermediate Level in Physics;

**For courses commencing in October 2022 or later:**

(a) **Applied Biomedical Science:** passes at Advanced Level at Grade C or better in Biology and Chemistry; and a pass at Intermediate Level in one of the following subjects: Applied Mathematics, Computing, Information Technology, Physics and Pure Mathematics.

(b) **Applied Food and Nutritional Sciences:** passes at Advanced Level at Grade C or better in Biology and Chemistry; and a pass at Intermediate Level in either Mathematics or Physics;

**Applicable for courses commencing in October 2023 or later:**

(b) **Applied Food and Nutritional Sciences:** a pass at Advanced Level at Grade C or better in Biology, a pass at Advanced Level in Chemistry, and a pass at Intermediate Level in either Mathematics or Physics;

**Applicable for courses commencing in October 2024 or later:**

(b) **Applied Food and Nutritional Sciences:** a pass at Advanced Level in Chemistry, and a pass at Intermediate Level at Grade C or better in Biology;

(c) **Communication Therapy:** two passes at Grade C or better, at least one of which must be at Advanced Level and one at Intermediate Level, in Biology and in either English or Maltese;

**Applicable for courses commencing in October 2024 or later:**

(c) **Speech Language Pathology:** two passes at Grade C or better, at least one of which must be at Advanced Level and one at Intermediate Level, in Biology and in either English or Maltese;

(d) **Mental Health Nursing:** a pass at Grade C or better in Biology at Intermediate Level, or a pass at Advanced Level in Biology, provided that applicants in possession of a pass in the MCAST-BTEC Extended Diploma in Health and Social Care (Health Studies) or the MCAST Advanced Diploma in Health Sciences, together with the MCAST Level 5 Award in Health Sciences shall be considered as having satisfied both the general and special entry requirements.

**Applicable for courses commencing in October 2023 or later:**

(d) **Mental Health Nursing:** applicants in possession of a pass in the MCAST-BTEC Extended Diploma in Health and Social Care (Health Studies) or the MCAST Advanced Diploma in Health Sciences, together with the MCAST Level 5

Award in Health Sciences shall be considered as having satisfied the general entry requirements;

(e) **Midwifery:** a pass at Advanced Level in Biology;

(f) **Nursing:** (i) successful completion of a values-based test, provided that for admission in October 2020 only, applicants in possession of a pass in the MCAST-BTEC Extended Diploma in Health and Social Care (Health Studies) or the MCAST Advanced Diploma in Health Sciences, together with the MCAST Level 5 Award in Health Sciences shall be considered as having satisfied both the General Entry and the values-based Requirements.

(ii) Applicants not in possession of the General Entry Requirements may be admitted to the Course if they obtain a pass in the 60 ECTS credits of the Preparatory Course specifically related to Nursing as detailed in Appendix I to these bye-laws. Applicants are required to complete the Preparatory Course programme immediately prior to the commencement of the Course. The requirements for admission and successful completion of the Preparatory Course are listed in Appendix I to these bye-laws;

**Applicable for courses commencing in October 2023 or later:**

(f) **Nursing:** (i) No special course requirements. Applicants not in possession of the general entry requirements shall still be eligible to join the Course if they are in possession of a pass in the MCAST-BTEC Extended Diploma in Health and Social Care (Health Studies) or the MCAST Advanced Diploma in Health Sciences, together with the MCAST Level 5 Award in Health Sciences.

(ii) Applicants not in possession of any of the qualifications indicated in sub-paragraph (i) of this paragraph may be admitted to the Course if they obtain a pass in the 60 ECTS credits of the Preparatory Course specifically related to Nursing as detailed in Appendix I to these bye-laws. Applicants are required to complete the Preparatory Course programme immediately prior to the commencement of the Course. The requirements for admission and successful completion of the Preparatory Course are listed in Appendix I to these bye-laws;

**Applicable for courses commencing in October 2024 or later:**

(f) **Nursing:** (i) No special course requirements;

(ii) Adult learners applying for admission in terms of regulation 6(c) of the Admissions Regulations may be required to sit for and pass an interview. In preparation for the interview, applicants shall be required to submit an updated *Curriculum Vitae* and a letter of motivation, written in English, explaining why they are applying for the Course (following guidelines provided by the

Department). The interviewing board appointed by the Board of Studies shall be composed of at least three members; and

(iii) Applicants who are not in possession of the general entry requirements or adult learners who are unsuccessful at the interview referred to in sub-paragraph (ii) of paragraph (f) of this bye-law, may be admitted to the Preparatory Course specifically related to Nursing as detailed in Appendix I to these bye-laws. Such applicants will be eligible to proceed to the Course if they successfully complete all the study-units included in the programme for the Preparatory Course immediately prior to the commencement of the Course. The requirements for admission and successful completion of the Preparatory Course are listed in Appendix I to these bye-laws.

(g) **Occupational Therapy:** a pass at Advanced Level at Grade C or better in Biology;

(h) **Physiotherapy:** a pass at Advanced Level at Grade C or better in Biology; and a pass at Intermediate Level in Physics;

(i) **Podiatry:** a pass at Advanced Level at Grade C or better in Biology and a pass at Intermediate Level in either Chemistry or Physics; and

(j) **Radiography:** a pass at Advanced Level in Biology. Applicants shall be required to be aged not less than 18 years within three months from the date on which the Course commences.

**Applicable for courses commencing in October 2023 or later:**

(j) **Radiography:** a pass at Advanced Level in Biology or Physics or Chemistry. Applicants shall be required to be aged not less than 18 years within three months from the date on which the Course commences.

4. The Admissions Board, acting on the advice of the relevant Board of Studies, may admit applicants into the second or third year of the Course with the same area of study taken in their Higher Diploma or Diploma, in terms of paragraph (1) of regulation 15 of the Admissions Regulations of the University, if in possession of the following:

(a) the Higher Diploma in Health Science or the Diploma in Health Science awarded by the University of Malta; or

(b) a professional qualification deemed by Senate to be comparable to the qualifications indicated in paragraph (a) of this bye-law.

5. During the first year of the Course, students are also required to undergo an occupational health assessment so as to ascertain that they are fit for the duties related to their proposed studies. Students who do not fulfil this requirement may be

barred from progressing with their studies. Failure to disclose information about a physical or mental health problem that could affect patient safety is considered to be a serious breach of the University Suitability to Practise Regulations.

### **Course Duration**

6. (1) The Course for the following areas shall extend over a period of four years of full-time study, or their equivalent in part-time study: Applied Biomedical Science, Communication Therapy, Midwifery, Occupational Therapy, Physiotherapy, Podiatry, and Radiography.

#### **Applicable for courses commencing in October 2024 or later:**

6. (1) The Course for the following areas shall extend over a period of four years of full-time study, or their equivalent in part-time study: Applied Biomedical Science, Applied Food and Nutritional Sciences, Midwifery, Occupational Therapy, Physiotherapy, Podiatry, Radiography and Speech Language Pathology.

(2) The Course for the Applied Food and Nutritional Sciences, Mental Health Nursing and Nursing areas shall extend over a period of three years of full-time study, or their equivalent in part-time study.

#### **Applicable for courses commencing in October 2023 or later:**

6. (1) The Course for the following areas shall extend over a period of four years of full-time study, or their equivalent in part-time study: Applied Biomedical Science, Applied Food and Nutritional Sciences, Communication Therapy, Midwifery, Occupational Therapy, Physiotherapy, Podiatry, and Radiography.

(2) The Course for the Mental Health Nursing and Nursing areas shall extend over a period of three years of full-time study, or their equivalent in part-time study.

### **Areas of Study**

7. The Degree may be awarded in terms of these bye-laws in any one of the following areas of study: Applied Biomedical Science, Applied Food and Nutritional Sciences, Communication Therapy, Mental Health Nursing, Midwifery, Nursing, Occupational Therapy, Physiotherapy, Podiatry, and Radiography or in any other area related to Health Sciences, following approval of Senate.

**Applicable for courses commencing in October 2024 or later:**

7. The Degree may be awarded in terms of these bye-laws in any one of the following areas of study: Applied Biomedical Science, Applied Food and Nutritional Sciences, Mental Health Nursing, Midwifery, Nursing, Occupational Therapy, Physiotherapy, Podiatry, Radiography and Speech Language Pathology or in any other area related to Health Sciences, following approval of Senate.

8. The areas of study offered in any particular year and the respective mode of attendance, shall be published by the Board before the commencement of each Course.

9. (1) Senate, on the advice of the Board, may limit the number of students that may be admitted to the Course in any or all of the areas of study and shall approve bye-laws for the selection of applicants to the Course in the area/s of study where the number of students that may be admitted is limited. The Board shall announce the number of places available to Maltese and other EU/EEA nationals, and possibly to non-EU/EEA nationals, prior to the commencement of the Course.

(2) Any places for non-EU/EEA nationals shall be filled on the recommendation of the Faculty Admissions Committee that may first consider eligible applicants recommended in terms of agreements the University may enter into with foreign institutions or governments.

**Course Programme**

10. Applicants shall be required to indicate their choice of area of study at the time of applying for admission to the Course.

11. The programme of study for each area of study shall have two distinct, although interdependent components, one theoretical, and the other practical/clinical.

12. Subject to changes that the Board may, with the approval of Senate, be constrained to make, students are bound to follow the study-units and obtain the credits as indicated in the course programme and in the programme of study of the area of study they are following for the Degree, Provided that course programmes and programmes of study are drawn up in accordance with the relevant provisions of the Principal Regulations.

13. Students admitted in terms of bye-law 5, who would have successfully completed the Certificate in Clinical Nursing Practice course with the same area of study for which they are being accepted, will be allowed to transfer the study-units passed during the Certificate course to the course leading to the Degree on condition that they renounce the Certificate.

**Applicable for courses commencing in October 2022 or later:**

13. Students admitted in terms of bye-law 4, who would have successfully completed the Certificate in Clinical Nursing Practice course with the same area of study for which they are being accepted, will be allowed to transfer the study-units passed during the Certificate course to the course leading to the Degree on condition that they renounce the Certificate.

**Conditions for Re-assessment of Practical/Clinical Study-Units**

14. (1) Students who fail a clinical practice study-unit or a study-unit involving a practical placement may be required to repeat the study-unit during the summer months before being re-assessed, or if such an arrangement is found not to be possible, re-do the study-unit in an additional year of study.

(2) The conditions for the re-assessment of such study-units shall be indicated in the description of each study-unit that is published in the catalogue.

**Repeat of the Final Year of Study**

15. The results obtained during the failed year shall not be taken into consideration for the award of the Degree and shall not be included in the student's academic record, provided that, at the discretion of the Board, students registered in a degree comprising both clinical/practical and theoretical components and whose overall Year Average Mark is at least 50%, may be allowed to retain the credits obtained in a successfully completed component but shall be required to repeat the failed component in its entirety.

**Classification of the Award**

16. The overall evaluation of each student's performance shall be based on the results obtained in each year of the Course weighted according to the following criteria:

For courses of three years' duration:

First Year Average Mark	30%
Second Year Average Mark	30%
Third Year Average Mark	40%.

For courses of four years' duration:

First Year Average Mark	15%
Second Year Average Mark	25%



Third Year Average Mark 25%  
Fourth Year Average Mark 35%,

provided that for the following areas of study, the results obtained in each year of the Course shall be weighted as follows:

**Applied Biomedical Science and Occupational Therapy:**

First Year Average Mark 10%  
Second Year Average Mark 25%  
Third Year Average Mark 30%  
Fourth Year Average Mark 35%.

**Radiography:**

First Year Average Mark 15%  
Second Year Average Mark 25%  
Third Year Average Mark 30%  
Fourth Year Average Mark 30%.

**Applicable for courses commencing in October 2023 or later:**

16. The overall evaluation of each student's performance shall be based on the results obtained in each year of the Course weighted according to the following criteria:

For courses of three years' duration:

First Year Average Mark 30%  
Second Year Average Mark 30%  
Third Year Average Mark 40%.

For courses of four years' duration:

First Year Average Mark 15%  
Second Year Average Mark 25%  
Third Year Average Mark 25%  
Fourth Year Average Mark 35%,

provided that for the following areas of study, the results obtained in each year of the Course shall be weighted as follows:

**Applied Biomedical Science and Occupational Therapy:**

First Year Average Mark 10%  
Second Year Average Mark 25%  
Third Year Average Mark 30%

Fourth Year Average Mark 35%.

**Applied Food and Nutritional Sciences:**

First Year Average Mark 15%  
Second Year Average Mark 20%  
Third Year Average Mark 30%  
Fourth Year Average Mark 35%.

**Radiography:**

First Year Average Mark 15%  
Second Year Average Mark 25%  
Third Year Average Mark 30%  
Fourth Year Average Mark 30%.

**Special Provisions for Part-Time Courses**

17. The provisions of the foregoing bye-laws shall apply *mutatis mutandis* to courses followed on a part-time basis, and subject to such changes as may reasonably be deemed by the Board of Studies as necessary due to the part-time nature of the Course.

## APPENDIX I

### The Preparatory Course

1. In order to be admitted to the Preparatory Course for the Nursing area of study, applicants are required to be in possession of one of the following:

(a) passes at Grade 3 or better in the Secondary Education Certificate Examination in six subjects, including Maltese, English Language and Mathematics; or

(b) passes in the Secondary Education Certificate Examination in six subjects, including: Maltese, English Language, Mathematics and either Biology or Health and Social Care, together with a pass at Advanced Level in any other subject; or

**For courses commencing in October 2023 or later:**

(b) passes in the Secondary Education Certificate Examination at grade 5 or better in six subjects, including: Maltese, English Language, Mathematics and either Biology or Health and Social Care, together with a pass at Advanced Level in any other subject; or

**For courses commencing in October 2024 or later:**

(b) passes in the Secondary Education Certificate Examination at grade 5 or better in six subjects, including: Maltese, English Language and Mathematics together with a pass at Advanced Level in any other subject.”

**Paragraph (c) shall be deleted for courses commencing in October 2024 or later:**

(c) the MCAST-BTEC Extended Diploma in Health and Social Care (Health Studies) or the MCAST Advanced Diploma in Health Sciences, or equivalent.

2. Applicants are further required to be aged not less than 18 years within three months following the date on which the Preparatory Course commences.

3. During the first semester of the Preparatory Course, accepted applicants are also required to undergo an occupational health assessment, so as to ascertain that they are fit for the duties related to their proposed studies. Students who do not fulfil this requirement may be barred from progressing with their studies. Failure to disclose information about a physical or mental health problem that could affect patient safety is considered to be a serious breach of the University Suitability to Practise Regulations.

4. The Preparatory Course shall consist of a number of study-units to which 60 ECTS credits are assigned and shall extend over a period of one year of full-time study.

5. Subject to changes that the Board may, with the approval of Senate, be constrained to make, students are bound to follow the study-units and obtain the credits as indicated in the programme of study for the Preparatory Course they are following.

6. Students shall be considered as having successfully completed the Preparatory Course if they obtain all the credits as outlined in the programme of study and obtain an average mark of 55%.

7. The provisions regarding assessment, progression and successful completion of the Preparatory Course, and any other provisions not outlined in this Appendix to these bye-laws shall be those stipulated in the Principal Regulations and shall apply *mutatis mutandis*.
