	MQF2: Outline benefits of proper personal presentation when working with clients.	1b	1	Award 0.5 marks for each outline.	<p>Candidates are expected to outline the following TWO benefits:</p> <ul style="list-style-type: none"> • Feeling proud and showing pride in one's job. • Looking professional and giving a good impression. <p>Example of a good outline: When a therapist presents herself properly, it shows the clients that she is feeling proud of being a therapist and that she has pride in her job.</p> <p>Accept any other relevant answer.</p>

Candidates are expected to describe any TWO consequences from the following: Cross contamination, unpleasant working atmosphere, loss of clients, bad reputation. Example of a good description: Cross contamination: if the therapist / stylist does not wash her hands regularly and disinfects and sterilises all tools after each client, cross contamination can happen because bacteria and viruses can be passed on to clients and stylists. Accept any other relevant answer.

Candidates are expected to give a good description of the hair growth cycle: Example of a description: The first two stages of the hair growth cycle are Anagen and Catagen. Anagen is the growth phase. During this phase, rapid cell division occurs in the hair bulb and dermal papilla. New hairs begin to protrude from the scalp. Catagen is the next phase. Cell division stops and colour pigments stop producing pigments. Accept any other relevant description.

	MQF 1: Name different hair and skin types.	3a	1	Award 0.25 for each hair type and 0.25 for each skin type named.	Candidates are expected to name any TWO hair types and any TWO skin types from the following: Hair types: wavy, straight, curly Skin types: oily, dry, normal, combination.
	MQF 2: Identify which tests need to be performed before a shampoo and facial service.	3b	1	Award 0.25 mark for each correct test.	Candidates are expected to identify the following TWO tests performed before a shampoo service and TWO tests performed before a facial service: Before a shampoo service: infestations; allergies, elasticity. Before a facial service: elasticity; muscle tone. (Accept allergies too in relation to facial service)

					<p>Example of a good description: The purpose of carrying out an elasticity test on the skin before a facial service is to determine which treatment and products the therapist will choose to work with so that the treatment/products can improve the condition of the skin.</p> <p>Accept any other relevant descriptions.</p>

	MQF 1: Identify the important factors that need to be considered during a client consultation.	4a	2	Award 0.5 mark for each factor identified.	<p>Candidates are expected to identify the following factors: Factor 1: adverse or incompatible conditions. Factor 2: hair growth patterns. Factor 3: clients' requirements and concerns Factor 4: head/face shape</p>
	MQF 2: Describe factors that may prevent a choice of service during a consultation.	4b	2	Award 1 mark for each factor described.	<p>Candidates are expected to describe any TWO from the following factors: incompatibilities; hair condition; hair disorders, hair infections and infestations; any skin allergies and/or contraindications.</p> <p>Example of a description: A factor that may prevent a choice of service are hair disorders. This is because if a hair disorder is ignored, the client's hair condition can be worsened. There are different hair disorders, that limit or prevent a service.</p> <p>Accept any other relevant description.</p>

	MQF 3: Discuss limiting factors and contra-indications that may prevent a choice of service during a consultation.	4c	2	Award 0.5 marks for each limiting factor and 0.5 marks for each contraindication discussed.	<p>Candidates are expected to discuss the following limiting factors and contraindications: incompatibility to para dye; pregnancy; time; hair length.</p> <p>Example of a good discussion of a contraindication: One contraindication that may prevent a choice of service during a hair consultation is incompatibility to para dye. Using permanent dye on this client group may harm the client due to one of the chemicals found in dyes.</p> <p>Example of a good discussion of a limiting factor: One limiting factor that may prevent a choice of service during a beauty consultation is time. If during the consultation, then the client is not informed about the length of time the treatment takes, the client may not be able to stay for the whole treatment and the end result may differ from the client's expectations.</p> <p>Accept any other relevant answers.</p>

	MQF 1: Describe the appropriate personal protective equipment that needs to be worn while providing different services.	5a	2	Award 1 mark for each answer given.	<p>Candidates are expected to describe ONE PPE for a cutting service and ONE PPE for a facial service.</p> <p>Any of the following answers can be accepted: Uniform Closed shoes</p> <p>PPE for a cutting service:</p> <p>Example of a good description: Closed shoes should be worn during a cutting service. Apart from being more hygienic it also protects the therapist or stylist from any unwanted accidents such as scissors being accidentally dropped and piercing the skin and avoiding any unwanted hair trimmings coming into contact with the skin.</p> <p>Accept any other relevant description.</p>
	MQF 2: Explain the different types of disinfection and sterilisation used in the salon.	5b	2	Award 1 mark for each explanation.	<p>Candidates are expected to explain how the following types of disinfection and sterilisation methods are used in a salon:</p> <ul style="list-style-type: none"> • UV cabinet • Autoclaves

					<p>Example of a good explanation:</p> <p>Autoclaves: These are used to sterilize salon equipment by subjecting them to very high-pressure saturated steam for about 15 to 20 minutes. Only metal tools should be put in an autoclave as any type of plastic or rubber will melt.</p> <p>Accept any other relevant explanations.</p>
	MQF 3: Evaluate the effectiveness of each type of disinfection and sterilisation used in the salon.	5c	2	Award 1 mark for each evaluation.	<p>Candidates are expected to evaluate the effectiveness of TWO disinfectants/sterilisers apart from UV cabinet and autoclaves.</p> <p>Example of a good evaluation:</p> <p>Chemical steriliser This method is often used in hairdressing and beauty salons. The tools are placed in a jar or container containing chemicals (sterilizing liquid) after they have been washed and cleaned to remove dirt. The chemical mixture must completely cover the tools. It is an effective method if used correctly. There are chemical sprays available for tools that cannot be immersed in liquid.</p> <p>No marks should be awarded if candidates evaluate the types given in question 5b.</p> <p>Accept any other relevant answers.</p>

	MQF2: Outline the use of different types of makeup brushes.	7b	1	Award 0.2 marks for each brush use outlined.	Outline the use of the following make-up brushes: <ul style="list-style-type: none">• Small eye shadow brush: for applying eyeshadow in the inner corners, and into the crease/socket area• Wide eyeshadow brush: for blending eyeshadow, for application of eye shadow across the eyelid.• Concealer brush: applying and blending out liquid, cream and powder concealer formulas.• Lip brush: to apply lipstick or lip gloss evenly to the lips• Blender brush: to blend eyeshadow for a smooth transition between colours and to create a cohesive look. It also makes the base of the makeup more long-lasting.</p> <p>Accept any other relevant answer.</p>

	Describe the effects of contouring and highlighting facial features.	8b	2	Award 1 mark for contouring description and 1 mark for highlighting description.	<p>Candidates are expected to describe the effects of contouring and highlighting facial features.</p> <p>Example of a good description: Contouring makeup helps to enhance facial bone structure. It makes use of shadowing to define the shape and features in the most flattering way to enhance the clients look.</p> <p>Accept any other relevant description.</p>

	Explain how makeup can correct client's facial shapes.	8c	2	Award 1 mark for each good explanation.	<p>Candidates are expected to explain how to correct a square and around face shape.</p> <p>Example of a good explanation:</p> <p>A square shaped face needs to be softened and is corrected by contouring the temples and the jawline with a contouring product. It is also highlighted at the centre of the face to enhance the square face shape.</p> <p>Accept any other relevant explanations.</p>
