	MQF 2: Match the fashion styles to the historic fashion periods.	1b	1	Award 0.25 marks for matching the fashion styles to each historic fashion period.	Candidates should match the following styles: i. 21 st Century ii. 19th Century iii. The Ancient World iv. The Renaissance
	MQF 3: Describe the key styles throughout different periods in fashion history.	1c	2	Award 0.5 marks for each description of the key style of fashion concerning colours and 0.5 marks about fabrics for each period.	Candidates should create sentences describing the popular colours and fabrics during each era. Appropriate explanation example: The Renaissance: During this period, styles varied with respect to fabrics, as the lower classes were forced to dress more practically. Lower-class people wore linen, a light, cool fabric made from flax, wool, or sheepskin. The upper classes had access to silk, satin, velvet, and brocade fabrics. Dark blue, yellow, red and green were the colours used for fabrics during the Renaissance. Accept any other appropriate descriptions.

	MQF 3: Describe formal elements that are used in fashion with reference to a particular body shape.	3c	2	Award 1 mark for each correctly described formal element suited for a pear body shape.	<p>Candidates should describe any TWO formal elements from the following: line, shape, colour, form, and texture categories.</p> <p>Example of a good description for a Pear Shape body:</p> <p>Shape: When designing clothes for pear shape body type, it is important to draw attention away from the wider hips and toward the upper body and defined waist. To achieve a balanced silhouette, you should emphasize the waist and minimize the lower body while giving the upper body the appearance of volume. The top half can be widened and proportions balanced with the aid of well-built shoulders.</p> <p>Accept any other appropriate description.</p>

Candidates are expected to outline TWO of the following body measurements required for making lower garment patterns. Body measurements for upper garments: Waist, bust/chest, shoulder, arm length, neck. An example of a good outline: Measure bust/chest – Place the tape measure around the bust making sure that it goes over the widest part and kept straight from the back. Accept any other appropriate answers.

C-3	MQF 1: Describe how body measurements should be taken for a given garment.	5a	2	Award 1 mark for each correct description.	<p>Candidates should describe the following TWO body measurements: Waist and hips measurements</p> <p>Example of a good description: Measure Hips -The widest part of the hips should be measured for hip measurements. You must locate the widest point for clothing to fit properly. After placing your tape measure, you might need to move up or down a few inches to find the widest spot. Because every person's body is unique, it might take a few repositioning attempts to make sure you are measuring the widest area.</p> <p>Accept other appropriate descriptions.</p>
	MQF 2: Explain the importance of pattern markings.	5b	2	Award 1 mark for each reason explained on the importance of pattern markings.	<p>Candidates are expected to explain TWO of the following reasons: perfect fitting, avoiding fabric being wrongly cut, guidance for sewing, and interpretation of the style.</p> <p>Example of a good explanation: Guidance for sewing. The tiny triangles on the edge of some pattern pieces are called notches. Double and even triple notches are occasionally visible. They are used to align other significant parts and align shoulder seams while sewing.</p>

					<p>Marking notches is important because they facilitate sewing by providing guidance on how the garment should be sewn together.</p> <p>Accept any other appropriate explanations.</p>
	MQF 3: Discuss the procedure that needs to be adopted before using a flat pattern.	5c	2	<p>Award 0.5 marks for every point discussed on the full procedure needed to be adopted before using a flat pattern in the correct order.</p>	<p>Candidates are expected to discuss the procedure that has to be adopted before using a flat pattern.</p> <p>The following FOUR points should be covered in the discussion:</p> <p>Adapt pattern to measurements; gather necessary notions; purchase the correct amount of fabric; prepare fabric.</p> <p>An example of a correctly description:</p> <p>Prepare fabric</p> <p>Prewash your fabric to avoid future volume changes and eliminate extra dye and chemicals from manufacturing. Dry your fabric. Although it is not required, using a tumble dryer is ideal because it will further pre-shrink your fabric. If you are using a fabric that needs to be dry cleaned and not washed, use your iron to steam the fabric to pre-shrink it. Your fabric should be ironed. It must be flat to cut your pattern pieces accurately. Verify that the fabric's grain lines are not distorted.</p> <p>Accept any other appropriate discussions.</p>

					<p>Appropriate explanation example: Fabric width 90cm Since the fabric is 90 cm wide, the skirt needs two lengths, depending on the actual length of the pattern of the skirt. The first length of the fabric is required for the front pattern piece, and the second length is necessary for the back pattern piece. The excess fabric from the sides can be used to cut the waistband. The amount of fabric needed for each design repeat should be considered carefully.</p> <p>Fabric width 150cm Since the fabric is wide, the skirt only requires one length of fabric, keeping in mind the actual length of the pattern. The excess fabric can be used to cut the waistband.</p> <p>Accept any other appropriate answers.</p>

An example of a good explanation: Job interview - Pencil Skirt It is acceptable to wear a pencil skirt to a job interview. A pencil skirt is frequently a stylish, business-casual option. This type of skirt should be knee-length that would give a formal and decent look. Also, pencil skirts should not be transparent and not too tight either. It goes well with a variety of stylish blouses and jackets. Accept any other appropriate answers.

It emphasises the waist band fastening, gives detail and embellishes the denim trousers.</p> <p>Accept any other appropriate answers.</p>
	MQF 3: Discuss chosen upper body garments to complement given styles of lower body garments for a particular occasion.	8c	2	Award 1 mark for each good discussion on an appropriate upper garment to go with the mentioned style.	<p>Candidates are expected to discuss a particular chosen upper body garment to complement each style.</p> <p>The discussion must include the following points:</p> <ul style="list-style-type: none"> - An appropriate upper body garment to go well with the lower body garment given. - Appropriate to particular occasion. - Appropriate for the season, - Appropriate colour to match the lower body garment. <p>An example of a valid discussion:</p> <p><i>Style A</i></p> <p>Appropriate to particular occasion: A loose style t-shirt is adequate since it provides the wearer freedom of movement.
