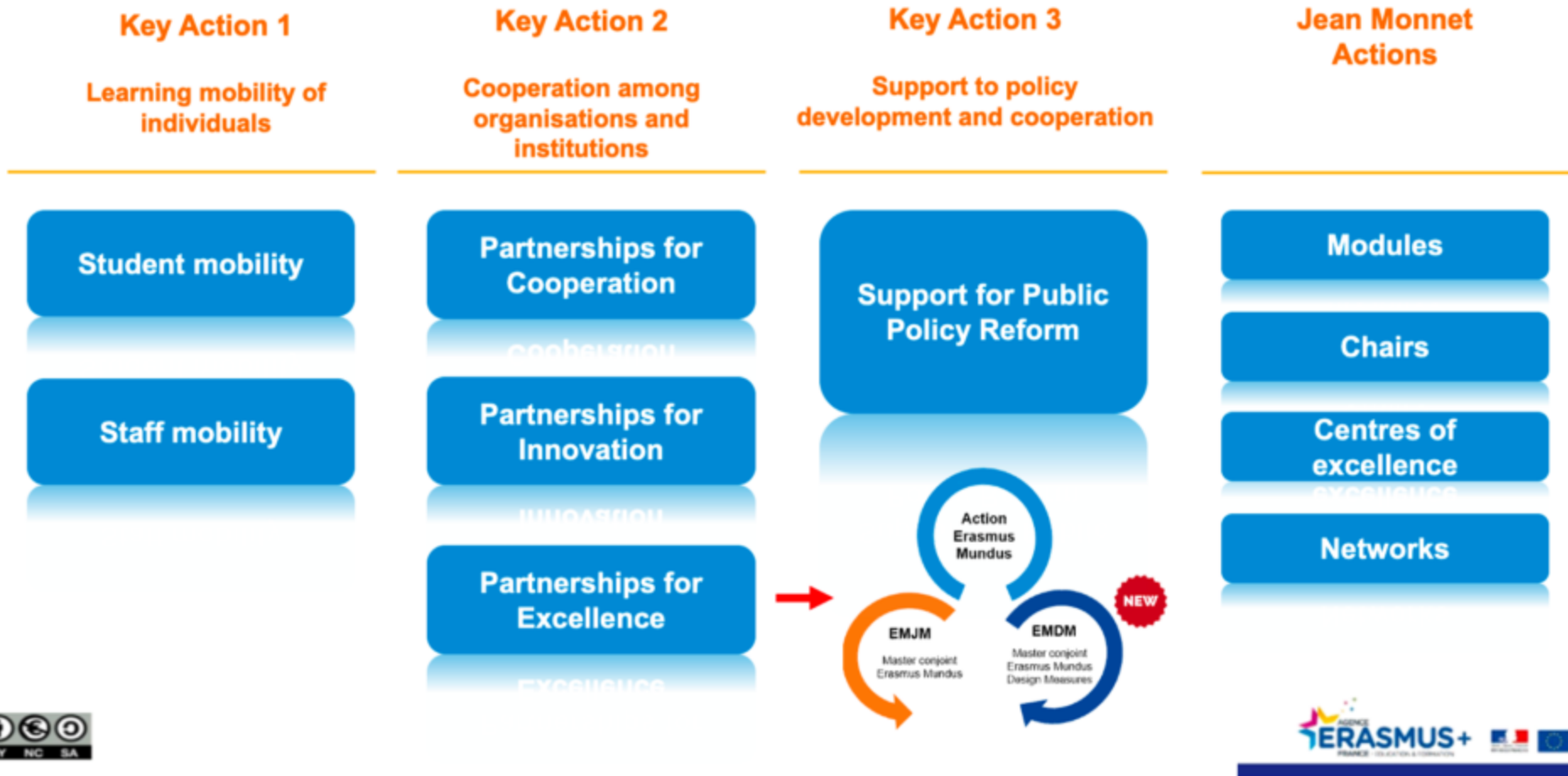

# Erasmus+ Framework

- ❑ Participation in the Erasmus+ Programme HEIs need to be Erasmus+ Charter for Higher Education.
- ❑ UM ECHE was renewed in 2020 for the period 2021-2027
- ❑ Inter-Institutional Agreements with partner HEIs, enable the different types of mobilities available

... is also to foster employability, social inclusion, civic engagement, innovation and environmental sustainability in Europe and beyond

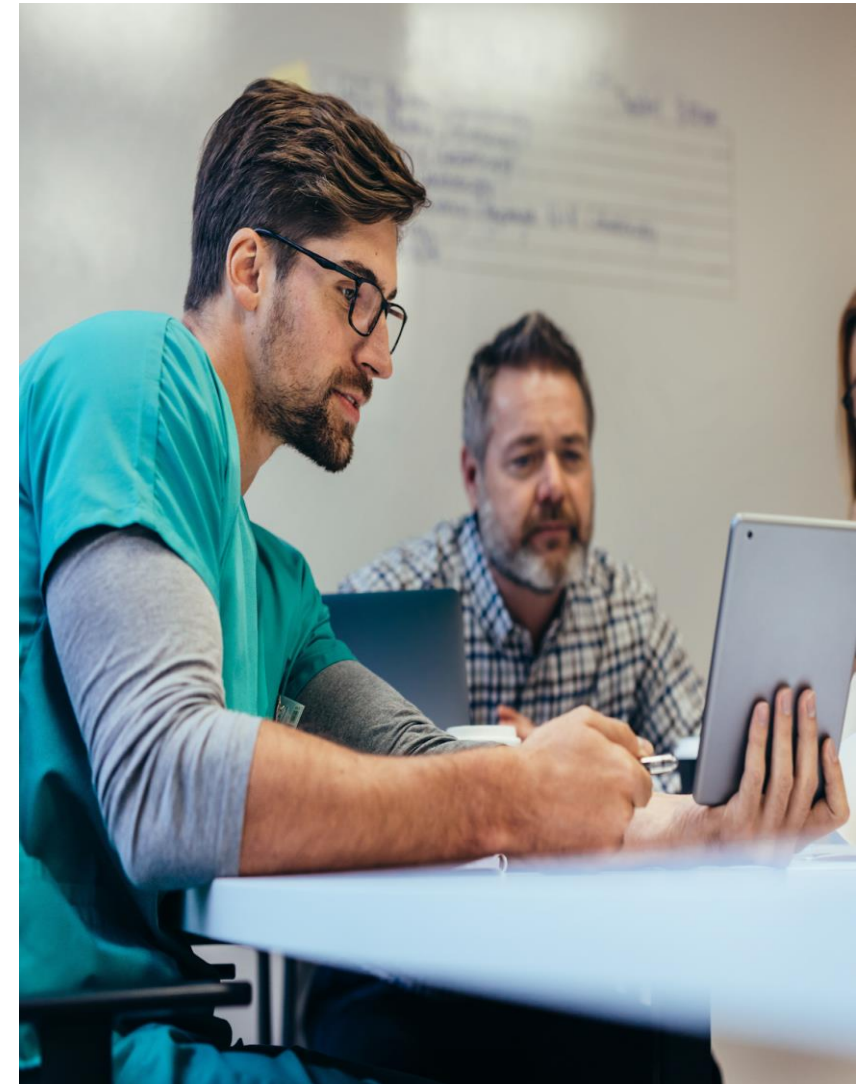

# Erasmus+ Staff Mobility



## Erasmus+ Staff Mobility

- ❑ Two types of Erasmus Staff Mobility:
  - for Training and
  - for Teaching
- ❑ Staff mobility for Teaching requires a minimum of 8 hours teaching per week or part of
- ❑ Staff Mobility can be a combination of Teaching and Training, in which case minimum teaching is reduced to 4 hours week
- ❑ Council appointed members of staff are eligible to apply
- ❑ Duration maybe between 2 days and 2 months. May be restricted due to funding limitations



# Erasmus+ Staff Mobility

- ❑ A Call for Staff Mobility applications is currently open. Applications are available on the IO website (requiring personal information, details about the Erasmus+ mobility experience and participation in Erasmus+ in general)
- ❑ Eligibility period: 1<sup>st</sup> August 2022 to 30<sup>th</sup> September 2023
- ❑ Deadline for applications is the 13<sup>th</sup> May 2022
- ❑ Applications are assessed by 2 international independent assessors
- ❑ Results are confirmed by the Erasmus+ Staff Grant Allocation Committee.

# Erasmus+ Student mobility

- ❑ Two types of Erasmus+ Student mobilities:
  - for studies and
  - for traineeships
- ❑ All registered students at University of Malta (undergraduate, postgraduate and doctoral level)
- ❑ Up to 12 months of mobility for each study cycle (UG, PG and PhD).
- ❑ Study mobilities must take place during designated mobility semesters, usually at UG level
- ❑ Student mobilities for traineeships are more flexible in terms of scope, timing and host organisation

# Erasmus+ Financial Support for Student and Staff Mobility

## Travel Support

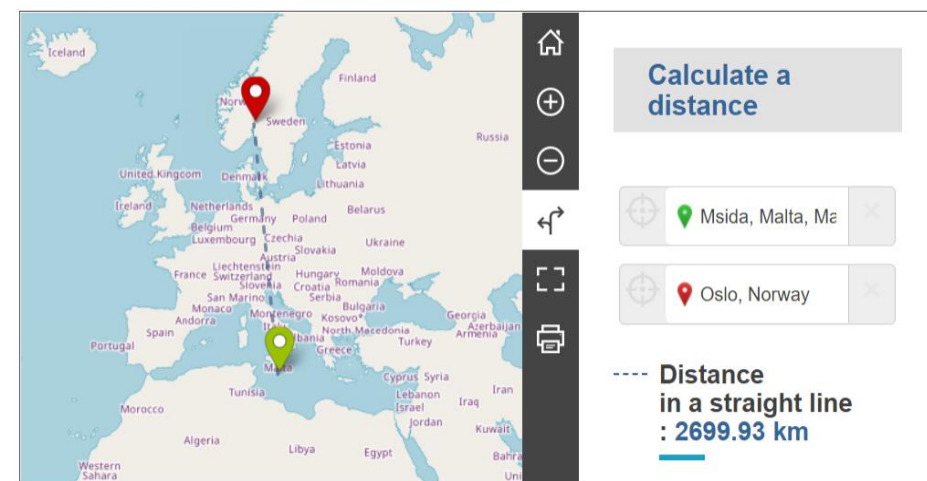
Travel distances	Amount
Between 10 and 99 KM:	EUR 20 per participant
Between 100 and 499 KM:	EUR 180 per participant
Between 500 and 1999 KM:	EUR 275 per participant
Between 2000 and 2999 KM:	EUR 360 per participant
Between 3000 and 3999 KM:	EUR 530 per participant
Between 4000 and 7999 KM:	EUR 820 per participant
8000 KM or more:	EUR 1500 per participant

Travel Support is a one time payment to each participant

Individual Support is calculated as follows:

Duration of Mobility x monthly rate for the destination country


Example

Mary will go on mobility to the University of Oslo, Norway for 4.5 months

Individual support eligible =  $4.5 \times \text{€ } 770 \text{ euro p/month} = \text{€}3375$

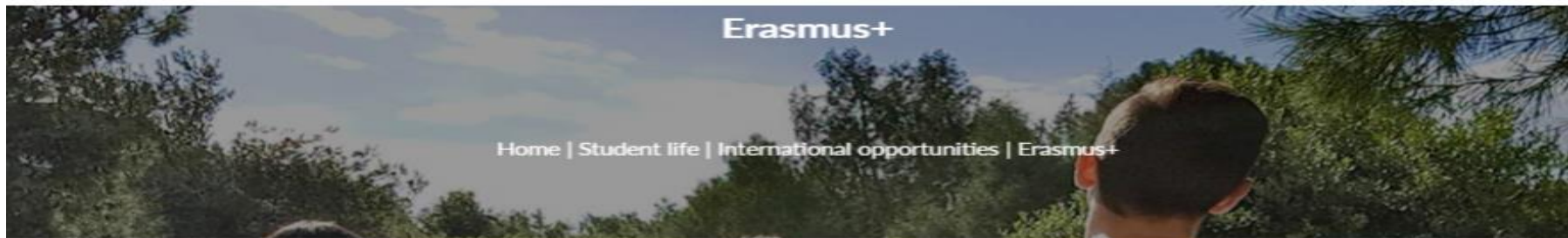

# Inclusion Support

- Health-related conditions that last one year or more, which requires ongoing medical attention and/or limit activities of daily living, can be considered as 'special needs'
- To benefit, complete the Inclusion section on the application form to be considered for additional support and funding available
- Provision of supporting documents to confirm conditions claimed is necessary to be eligible







# Erasmus+

Erasmus+ is the EU Programme in the fields of education, training, youth and sport. It is the EU's flagship education and training programme, emphasises student and staff mobility and European cooperation involving higher education institutions and other key players in the knowledge-based economy. It supports the creation of a European Higher Education Area (EHEA) through increased mobility, to allow for innovation, growth and jobs in the EU. On the 25th March 2021, Erasmus+ 2021-2027 was launched by the European Commission, to continue building on the results achieved so far.

The [Erasmus Charter for Higher Education](#) provides the general framework for the European Cooperation activities a higher education institution (HEI) may carry out within the Erasmus programme. The [Erasmus Policy Statement](#) provides an overview of the University of Malta International Strategy.

With the Extended Erasmus University Charter, the University of Malta is entitled to apply for Erasmus funding for student mobility for studies and for traineeships, as well as for the transnational mobility activities for staff members both Academic and Administrative, as well as participate in projects funded under the Erasmus+ programme.

# Erasmus+ International Credit Mobility


- ❑ Opportunity for HEI to undertake exchanges with partners for non-EU/EEA countries
- ❑ Also based on Inter-Institutional Agreements
- ❑ Funding focusing solely on mobilities but this action can be used to support cooperation with non-EU/EEA countries
- ❑ Erasmus+ ICM requires a very detail application and is evaluated in a different manner than the European Erasmus+
