- 1. The Department of Systems and Control Engineering requires the services of a Research Support Assistant (RSA) / Research Support Officer (RSO) to assist with the Department's computer vision research, with current focus on vision-based eye movement extraction, and on thermography-based skin lesion analysis.
- 2. The ideal candidate should:
  - a. Be, at least, in the third-year of a Bachelor's degree (for RSA), have a Bachelor's degree (for RSO I) or Master's degree (for RSO II), in an area of study related to electronic or computer engineering, computing, physics, mathematics, or any other area deemed to be related to the post;
  - b. Programming competence in Matlab and/or Python;
  - c. Good written and spoken communication skills and academic writing skills in English.
- 3. This post will be for a period from 1<sup>st</sup> January 2026 until 31<sup>st</sup> December 2026 and the Research Support Assistant / Research Support Officer will be expected to work a total maximum of 520 hours (RSA), 359 hours (RSO I) or 320 hours (RSO II). The remuneration (inclusive of any cost-of-living adjustment) will be at a rate of €9.02 per hour (RSA), €13.08 per hour (RSO I) or €14.58 per hour (RSO II).
- 4. The selected candidate must be living in Malta for the period of employment.

- 2. The main duties and responsibilities of the appointee/s will consist of carrying out Research and Project Management Assistant duties including:

  - b. produce deliverables and related reports within the stipulated time frames as specified in the project description;
  - c. keep detailed progress reports and abide to all the conditions imposed by the project;
  - d. endeavour in generating technical and scientific conference/journal papers;
  - e. assist in the dissemination process via workshops, seminars and other events;
  - f. perform any other tasks as instructed by the project coordinator and key experts.
- 3. The appointee is expected to work:
  - a. on a part-time basis; and
  - b. at such places and during such hours as may be determined by the University authorities.
