## HSL5004 Implementation of Integrated Safety Across the Levels of the Healthcare Ecosystem MQF Level 7 10 ECTS Credits

**Available for:** Qualified health care professionals, who hold a professional registration with a regulatory body recognised by the UM, managers and leaders of health and social care entities, who hold a first degree recognised by the UM and qualified health risk and health insurance professionals, who hold a first degree recognised by the UM. The study-unit listed above is delivered in a hybrid manner – face-to face and online.

MID3118 Spirituality in Midwifery

**MQF** Level 6

**4 ECTS Credits** 

**Available for:** Qualified midwives who hold a professional registration with a regulatory body recognised by the UM. The study-units listed above is delivered face to face mostly asynchronous manner. Proficiency in basic IT skills is a prerequisite.

Limited to 20 students.

CPD study-unit fee: €260

**RAD5004** Radiation Safety Principles 2

**MQF** Level 7

**5 ECTS Credits** 

**Available for:** Qualified radiographers and other health care professionals who hold a professional registration with a regulatory body recognised by the UM and who demonstrate that they perform duties and have an interest in radiation safety across specialised modalities, including Computed Tomography (CT), Nuclear Medicine & PET/CT, and Radiotherapy.

The study-unit listed is delivered in an online mostly asynchronous manner. Proficiency in basic IT skills is a prerequisite.

Limited to 20 students, with preference given to (i) radiographers registered with the local regulatory body (CPCM); (ii) those demonstrating the need to fulfil refresher radiation safety training requirements outlined in local legislation; (iii) those who are completing/have completed the micro-credential RAD5003 – Radiation Safety Principles 1.

# RAD5005 Fundamentals of MRI: Physics and Clinical Applications (Blended) MQF Level 7 5 ECTS Credits

**Available for:** Qualified radiographers who hold a professional registration with a regulatory body recognised by the UM and who have an interest or a need in refreshing and updating their knowledge about the basic principles underpinning magnetic resonance imaging (MRI). The study-unit is delivered in a blended manner. Proficiency in basic IT skills is a prerequisite.

Limited to 20 students with preference given to radiographers registered with the local regulatory body (CPCM) and who are performing duties within an MRI suite.

CPD study-unit fee: €325
