The programme of studies of the **B.A.** in **Disability Studies (joint area)** offers a diversity of topics, from empowerment, to rights and policies to art and cultural representation. If you have an interest in disability issues and want to engage with and learn more about this field, then this course will help you to achieve those goals.



The programme of studies of the **B.A.** in **Gender and Sexualities (joint area)** includes a diversity of topics, that offer the opportunity to consider and explore the various theories and perspectives on gender and sexualities, and the way they interact with other disciplines. Throughout the programme, you will learn how to demonstrate your knowledge and understanding about the main concepts and milestones underpinning the areas of gender and sexualities, the impact on different perspectives of everyday life, and the knowledge that has been gained over the last decades internationally, as well as explore how these have developed in the Maltese context.



The programme of studies of the **B.A.** in **Psychology** (joint area) allows for the study of human behaviour from an individual perspective. By studying this area, you will be learning about key movements, concepts, schools of thought and historical figures who have contributed to the field of Psychology as we know it today. You will be able to apply theoretical and empirical knowledge to applied areas such as social, clinical and organisational psychology in order to understand better individual human behaviour in the contexts in which it usually occurs.



The programme of studies of the **B.A.** in **Child & Family Studies (joint area)** provides a solid grounding in pertinent issues related to children and families from the most basic concepts to more specialised topics. You will be exposed to a range of topics from different professionals in the field. You will learn about the development of the family across the life-span, the impact of poverty on the family, understand the implications of interpersonal violence, sexuality in the family, gender issues, family-centred laws and policies, as well as ethical issues when working with families amongst others.



The programme of studies of the **B.A.** in **Gerontology** and **Dementia Studies** (joint area) delves into the complexities of gerontological, geriatric and dementia issues. This transformative programme will blend theory with practical applications, equipping you with the knowledge and compassion needed to make a positive impact on older lives. Engage in dynamic discussions, hands-on experiences, and fieldwork opportunities that prepare you for meaningful careers in healthcare, social services, and advocacy.



The programme of studies of the **B.A.** in European Studies (joint area) aims to provide you with an extensive knowledge of the European Union from a multi-disciplinary angle, involving the politics, economics, law and history of European Integration. A central aim of the course is to develop your analytical skills and to deepen your critical appraisal of EU policies and EU affairs in general. Special emphasis is also laid, where appropriate, on the deepening of knowledge of the theories and theoretical frameworks employed by the various disciplines in assessing EU politics and policies.
